Warning to NPCs to Alert Athletes Regarding Meldonium (Mildronate)

Dear Members,

Following a number of public cases featuring Meldonium (Mildronate) the International Paralympic Committee (IPC) would like to remind all National Paralympic Committees (NPCs) and Members that the substance has featured on World Anti-Doping Agency's (WADA) 2016 List of Prohibited Substances and Methods since 1 January 2016. The addition of Meldonium on the Prohibited List was released at the end of September 2015. We ask that you ensure your athletes are made aware of this information.

Meldonium (Mildronate) is a metabolic modulator, prohibited at all times, both in- and outof-competition. It is a cardioprotective medication available in some Eastern European countries in both oral capsules and solution for injection.

The IPC urges all athletes to double check all medications and supplements which could contain Meldonium. Athletes are also reminded of the Therapeutic Use Exemption (TUE) process that is required when an athlete needs a prohibited substance for a medically justified reason.
