Events: Number of players accepted for main rounds: MS - 64, WS - 64, MD - 32, WD – 32, XD – 48.

2.3 It is required that every event in a particular BEC U17 Circuit tournament has at least 8 competitors (i.e. actual competitors, not merely entries). If the required number of competitors is not met, this particular event shall not count towards any ranking.

In accordance with regulation § 9.4 in BWF Statutes, Section 5.3.3.2: World Junior Ranking System, an event must contain at least one entry from a Member Association other than the hosting Association. If an event does not contain at least one entry from a Member Association other than the hosting Association, this particular event shall not count towards any ranking.

BADMINTON EUROPE is not liable for any costs incurred by third persons (players, coaches, umpires, team managers etc.) because of an event not having enough competitors to count for the rankings.

Entries: 11.4 All entries must be made by using the BWF Online Entry System.

Entries must be submitted no later than Tuesday August 18, 2020 at 23.59 BWF HQ time (GMT +08.00).

11.1 Entries must be made by a Member Association of which the player/pair is a member.

11.8 No late entries will be accepted.

12.1 The Member Association that enters a player/pair into a BEC U17 Circuit tournament is responsible for paying the entry fees for that player/pair. The entry fees become due if a player is entered and has not been withdrawn when the entry deadline passes. It is recommended that the entry fees are paid by bank transfer, but the organisers can accept cash payments at tournaments.

12.2 The entry fees will not be refunded in the case of a withdrawal. For all the withdrawn players the organisers can invoice the entry fee to the relevant Member Association.

Players cannot be entered unless they already have a BWF ID-number. In case you wish to enter players who do not have a BWF ID-number, please contact the BWF office well in advance of the tournament, so that the players concerned can get a BWF ID-number before the closing date of the tournament.

GCR 7.9: “In making or authorising entries, the Member concerned is reconfirming its acceptance, and acceptance by the Players being entered, of the BWF’s regulations and Disciplinary processes.”

Conditions:

The tournament will be run strictly in accordance with the Competition Regulations of the BWF and the Regulations for Badminton Europe U17 Circuit 2020.

The tournament will be played on a knock-out system.

In the events of any dispute, the Referee’s decision shall be final.

No player shall be eligible to compete unless he/she is in good standing with his/her National Association.

**Badminton
Integrity:**

Section 2.4 of the BWF Statutes (Code of Conduct in Relation to Betting, Wagering and Irregular Match Results) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.

To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a matches.

- Doping Control:** Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.
