Players cannot be entered unless they already have a BWF ID-number. In case you wish to enter players, who do not have a BWF ID-number, please contact the BWF office well in advance of the tournament, so that the players concerned can get a BWF ID-number before the closing date of the tournament.

**Compliance with General Competition Regulations Clause 7.9**

GCR 7.9: "In making or authorising entries, the Member concerned is reconfirming its acceptance, and acceptance by the Players being entered, of the BWF's regulations and Disciplinary processes."

**No late entries will be accepted!**

**Entry fees** Singles: 25 Euro per player  
Doubles: 20 Euro per player

Entry fees shall be paid before the starting day of the competitions to the bank account of Turkish Badminton Federation. Payment receipt copy should be offered to tournament office before the first scheduled match, Cash Payment is not accepted.

The Member that enters a player/pair into a BEC U17 Circuit tournament is responsible for paying the entry fees for that player/pair. The entry fees become due if a player is entered and has not been withdrawn when the entry deadline passes.

The entry fees will not be refunded in the case of a withdrawal. For all the withdrawn players the organisers can invoice the entry fee to the relevant Member.

**Competition**              K.O. system according to the Laws of Badminton and Competition Regulations of the BWF.

**Minimum entries:** It is required that every event in a particular BEC U17 Circuit tournament has at least 8 competitors (i.e. actual competitors, not merely entries). If the required number of competitors is not met, this particular event shall not count towards any ranking.

In accordance with regulation § 9.4 in BWF Statutes, Section 5.3.3.2: World Junior Ranking System, an event must contain at least one entry from a Member other than the hosting Member. If an event does not contain at least one entry from a Member other than the hosting member, this particular event shall not count towards any ranking.

Of the BEC U 17 Circuit Regulations: "Cancellation of the tournament in case of force majeure in accordance with regulation 2.4 which says that *"The organising Member can cancel a tournament in case of force majeure. Such cancellation must be announced at least 15 days before the start of the tournament. If a cancellation is announced less than 15 days before the start of the tournament, then the Member organising the tournament is liable for any expenses incurred by third persons (players, coaches, umpires, team managers etc.). BADMINTON EUROPE is not liable for any costs incurred by third persons because of a cancellation of a tournament."*

2.6 of the BEC Circuit Regulations: "Member and/or Organiser may be liable for claims originating from the damages incurred by the participants and/or any other persons, arising from or in connection to the particular BEC Circuit tournament, according to local Law. BADMINTON EUROPE is not liable for any such claims, actions, damages, costs or expenses of any nature whatsoever, including but not limited to injury or loss to person or property, arising out of or in any way related, directly or indirectly, to the particular BEC Circuit tournament. It is recommended that Members and/or Organisers purchase a proper Insurance Policy that would cover their potential legal liability."

**Visa** If you need Visa for Turkey, ask the Turkish Badminton Federation for the official Invitation letter not later than 25 days before the Tournament. It is advised to arrange the VISA in time.

**Condition of play** The tournament will be played in full accordance with the Laws of Badminton and the Competition Regulations adopted by the BWF as well as the Circuit Instructions. Competitors must be prepared to play at the times determined for the events for which they have entered. Competitors will be scratched if not ready to play when called.

**Local transport** Provided by the organizer between the Ankara Esenboga International airport and the official hotels and between the official hotels and the sports hall.  
Accommodation demands and payments shall be sent directly to the Turkish Badminton, Otherwise Organizer has no responsibility for transport of the participants ( FOR FREE IF STAYING AT OFFICAL HOTEL )

**Medical service** A doctor will be present in the Sports hall during the tournament.

**Drug testing** Drug Testing may be carried out on a random basis at any time.

In applying these regulations, the decision of the Referee shall be final.

**Insurance** The organizer declines responsibility and covering of costs for possible injuries or other damages. It is up to each participant to insure himself.

**Doping Control**

Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.

Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

**Badminton Integrity**

Section 2.4 of the BWF Statutes (Code of Conduct in Relation to Betting, Wagering and Irregular Match Results) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.

To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.
