Events:

Men's (MS) and women's (WS) single, men's (MD) and women's (WD) double and mixed doubles (XD). According to BWF rules, players born 2004 or later can be accepted. The maximum number of competitors accepted in the tournament are:

48 players in men's and women's single

32 pairs in men's and women's double

32 pairs in mixed doubles

It is required that every event in a particular BEC U17 Circuit tournament has at least 8 competitors (i.e. actual competitors, not merely entries). If the required number of competitors is not met, this particular event shall not count towards any ranking.

In accordance with regulation § 9.4 in BWF Statutes, Section 5.3.3.2: World Junior Ranking System, an event must contain at least one entry from a Member other than the hosting Member. If an event does not contain at least one entry from a Member other than the hosting Member, this particular event shall not count towards any ranking.

Draw

All events will be played in knock-out system. The seeding and the draw will be made by Badminton Europe on **17th November 2020**.

Condition of play

The tournament will be played in full accordance with the Laws of Badminton and the Competition Regulations adopted by the BWF as well as the Badminton Europe's U17 Circuit Regulations. Competitors must be prepared to play at the time determined for the events for which they have entered.

Entry fees for the tournament are:

- EUR 30,00 per player in singles events
- EUR 50,00 euros per pair in doubles events

The Member that enters a player into a Circuit tournament is responsible for paying the entry fees for that player.

The entry fees become due if a player is entered and has not been withdrawn when the entry deadline passes. For all the players withdrawing in the meantime the organizers invoice the entry fee to the relevant Member.

Compliance with General Competition Regulations Clause 7.9

GCR 7.9: *“In making or authorising entries, the Member concerned is reconfirming its acceptance, and acceptance by the Players being entered, of the BWF’s regulations and Disciplinary processes.”*

No late entries will be accepted.

Doping Control

Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.

Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

Badminton Integrity

Section 2.4 of the BWF Statutes (Code of Conduct in Relation to Betting, Wagering and Irregular Match Results) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.

To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a matches.
