Late entries will not be accepted.
03c	Entry restrictions	<ul style="list-style-type: none"> a. Competitors must be members of a Member of the BWF. Participation is restricted to players born in the year 2004 or later. b. If the amount of entries exceeds the maximum amount as listed above in section b, a selection of entries will be made in the following order: <ul style="list-style-type: none"> i. Points on the European U17 Ranking. ii. Foreign players without points on the European U17 Ranking, drawn by lots (no country can have 2 (two) players/pairs without points participating before all entered countries have at least 1 (one) player/pair without points participating). iii. Home nation players in order of strength as listed by their Member. iv. The selection of entries shall be done by BADMINTON EUROPE. c. Entries must be done in order of strength.
03d	Draw Date	Seeding will be done by Badminton Europe. The draw will be made by Badminton Europe on 15 December 2020.
03f	Withdrawal Deadline	14 december 2020 at 23h59 CET
04	Link for entry	<p>All entries must be made by using the BWF Online Entry System : https://bwf.tournamentsoftware.com/sport/tournament?id=32FE7F05-C6D0-40AC-B8F2-E80257348D20</p> <p>It is required that every event in a particular BEC U17 Circuit tournament has at least 8 competitors (i.e. actual competitors, not merely entries). If the required number of competitors is not met, this particular event shall not count towards any ranking.</p> <p>In accordance with regulation § 9.4 in BWF Statutes, Section 5.3.3.2: World Junior Ranking System, an event must contain at least one entry from a Member other than the hosting Member. If an event does not contain at least one entry from a Member other than the hosting Member, this particular event shall not count towards any ranking.</p>

05a	Payments	<p>Entry fees are € 22,00 per competitor for the singles and € 40,00 per pair for the doubles.</p> <p>The Member that enters a player/pair into a BEC Junior Circuit tournament is responsible for paying the entry fees for that player/pair. The entry fees become due if a player is entered and has not been withdrawn when the entry deadline passes.</p> <p>The entry fees will not be refunded in the case of a withdrawal. For all the withdrawn players the organisers can invoice the entry fee to the relevant Member.</p> <p>Payment can be done prior to the start of the tournament by bank transfer according to payment instructions provided by email after registration.</p> <p>At the venue, cash payment of all fees due is possible before the start of the tournament. For cash payment an additional administrative fee of € 10,00 per payment is applicable.</p>

16c	Match Conditions	<ul style="list-style-type: none"> Competitors must be prepared to play 30 minutes before scheduled time. No exception will be made to this rule. An umpire and a service judge will be appointed for each match in semi finals and finals. For all other matches, the loser of a match will be umpire for the next match on the court he has played. In the teammanagers meeting this will be the proposal of the referee.
16c	Stringing	Stringing facilities will be offered in the venue for acceptable prices to pay by the competitor
17a	Compliance with GCR Clause 7.9	"In making or authorising entries, the Member concerned is reconfirming its acceptance, and acceptance by the Players being entered, of the BWF's regulations and Disciplinary processes."

17c	Drug Testing	<p>Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.</p> <p>Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if</p>

necessary, get a Therapeutic Use Exemption (TUE).
