The Member Association that enters a player/pair into a BEC Junior Circuit tournament is responsible for paying the entry fees for that player/pair. The entry fees become due if a player is entered and has not been withdrawn when the entry deadline passes.  The entry fees will not be refunded in the case of a withdrawal. For all the withdrawn players the organisers can invoice the entry fee to the relevant Member Association.  Payment can be done prior to the start of the tournament by bank transfer on account number IBAN NL23 RABO 0122 4330 41 (SwiftBIC RABONL2U) by BC Victoria.  At the venue, cash payment of all fees due is possible before the start of the tournament.  For cash payment an additional administrative fee of € 10,00 per payment is appli-
