GENERAL

The tournament will be run strictly in accordance with the BWF General Competition Regulations and the BEC Elite Circuit Regulations. The tournament will be played on a knock-out system. In the events of any dispute, the Referee's decision shall be final. No player shall be eligible to compete unless he/she is in good standing with his/her National Association.

ENTRIES

32 in singles, 32 in men's and women's doubles and 32 in mixed doubles in the main draw will be accepted.

If the amount of entries exceeds the maximum amount selection of entries shall be done by BADMINTON EUROPE.

16.7 No late entries will be accepted.

Compliance with General Competition Regulations Clause 7.9

GCR 7.9: "In making or authorising entries, the Member concerned is reconfirming its acceptance, and acceptance by the Players being entered, of the BWF's regulations and Disciplinary processes."

In accordance with regulation § 9.2 and § 9.3 in BWF Statutes, Section 5.3.3.1: World Ranking System, an event must contain at least 8 (eight) competitors in the first published version of the main draw. If the required number of competitors is not met in the first published version of the main draw, this particular event shall not count towards any ranking, i.e. BEC Elite Circuit Ranking and BWF World Ranking. In accordance with regulation § 9.4 in BWF Statutes, Section 5.3.3.1: World Ranking System, the first published version of the main draw of an event must contain at least 1 (one) entry from a Member other than the hosting Member. If an event does not contain at least 1 (one) entry from a Member other than the hosting Member, this particular event shall not count towards any ranking.

Badminton Europe is not liable for any costs incurred by third persons (players, coaches, umpires, team managers etc.) because of an event not having enough competitors to count for the rankings.

ENTRY FEES

17.1 The Member that enters a player into a BEC Elite Circuit tournament is responsible for paying the entry fees for that player. The entry fees become due if a player is entered and has not been withdrawn when the entry deadline passes.

17.2 The entry fees will not be refunded in the case of a withdrawal. For all the withdrawn players the organisers can invoice the entry fee to the relevant Member. Players cannot be entered unless they already have a BWF IDnumber. In case you wish to enter players who do not have a BWF ID-number, please contact the BWF office well in advance of the tournament, so that the players concerned can get a BWF IDnumber before the closing date of the tournament.

WITHDRAWALS & NO SHOWS

22.1 Any withdrawal after the Monday immediately preceding the draw, for any reason whatsoever, renders the Member concerned liable to an amount of US\$ 150,00 for the inconvenience caused by the withdrawal (as defined in BWF General Competition Regulations).

22.2 Any player not showing up for a match at the tournament, without having been withdrawn in advance, renders the Member concerned liable to an additional amount of US\$ 500,00 for the inconvenience caused by the "no show" (as defined in BWF General Competition Regulations).

CLOTHING AND ADVERTISING

18.1 Colour, design, lettering and advertising on clothing shall be regulated by BWF General Competition Regulations § 20 to 24. Any breach of these regulations will be forwarded to BWF.

18.2 It is mandatory that partners in doubles wear the same colour of the T-shirt and shorts/skirts at all time during play in both the qualification and the main draw. Failing to do so shall result in an administrative fine of 100,00 EUR.

DEPARTURE

9.5 Players shall not plan their departure less than 2 (two) hours after their last match is planned to conclude. If a player is unable to compete due to early departure, he/she will be penalised by removal of Elite Circuit ranking points and shall not be awarded prizes or prize money. BADMINTON EUROPE shall propose to BWF that the gained BWF ranking points are also removed.

TRANSPORT

City of Dnipro has an airport named International airport "Dnipro" (DNK) with connections with Kiev Borispol airport. You can also fly to Kharkov or Zaporozhye and then get train or bus to our city.

Distance between

- Kiev and Dnipro 500 km,
- Kharkov and Dnipro 250 km,
- Zaporozhye and Dnipro 100 km.

Transfer between Dnipro airport, railway station and the hotels, and also between the hotels and the venue will be provided by the organizer free of charge.

BADMINTON EUROPE is not liable for any costs incurred by third persons because of a cancellation of a tournament.

COVID-19

Please be aware that the tournament takes place during the current pandemic situation with COVID-19. The conditions for hosting the tournament, as well as hygiene, sanitary and preventive measures, will be those determined by the Ukranian authorities at all times. If the Ukrainian authorities require it, each participant may have to deliver a responsible declaration before participating in the tournament. Should the event be cancelled with short notice by the Ukrainianian authorities, due to the COVID-19 situation, beyond the control of both Badminton Europe and the Ukrainian Badminton Federation, neither of them will be liable for any costs related to travelling or accommodation made by players/officials for this event. Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

Section 2.4 of the BWF Statutes (Code of Conduct in Relation to Betting, Wagering and Irregular Match Results) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.

To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a matches.
