- Date of the draw: Tuesday, 7th June 2022 BEC responsibility
- The number of entries than can be accepted: MS 64, WS 64, MD 32, WD 32, XD 48
- Provisional schedule:
 - Friday, 24th June 2022 R64 MS, WS, XD / R32 MD, WD (10:00-21:00)
 - Saturday, 25th June 2022 R32 MS, WS, XD / R16 all events / QF all events (10:00-21:00)
 - Sunday, 26th June 2022 semi-final and final matches all events (09:00-14:00)
- Entry fees: 35 EUR per player per event MS & WS, 30 EUR per player per event MD, WD & XD (has to be paid in cash before the start of the competition)



- Team managers meeting: 23rd June (Thursday) at 20:00 competition venue
- Medical service: medical staff will be present in the hall for the whole duration of the competition
- Doping control: may be carried out on a random basis at any time
- Official Pansion: Milkaza (2*) 20 EUR per person per night incl. breakfast & taxes (1/2 1/6 rooms)
- Official Hotel: Sole Mio (4*) 30 Eur per person per night incl. breakfast, taxes, spa etc. (1/2 1/4)
- Accommodation booking closing date: 10th June 2022 (LIMITED CAPACITIES use Accommodation Booking Form) – has to be paid in cash before the start of the competition
- Other meals: lunch and dinner can be ordered in Pansion 6 EUR (full meal incl. soup & salad)
- Official point of arrival: Sports Center Slana Bara, Novi Sad
- Transportation service from Belgrade to Novi Sad: Belgrade Airport accommodation or competition venue in Novi Sad costs 50 EUR per person for both directions (use Transportation Booking Form)



- Shuttle Bus: organizer will provide Shuttle Bus service free of charge; the Shuttle Bus line will cover official Hotel, official Pansion, Competition and Training venue
- Insurance: organizer of the competition will not be held responsible for all legal and financial issues regarding health of competitors and other participants regardless of age, gender or category before, during or after this competition
- Competition regulations: Serbian U17 International Novi Sad 2022 will be conducted under the BWF General Competition Regulations and in accordance with the regulations of the Badminton Europe U17 Circuit Regulations
- Clothing and advertising: Serbian U17 International Novi Sad 2022 will be conducted according to the BWF Statutes, Section 5.2.3: Junior Tournament Regulations 12 to 16 on advertising and clothing and according to the BEC U17 Circuit Regulations on clothing
- Visa application process: after entering a player(s) in the tournament it is the Member's responsibility to secure visas for their players if this is needed; Member's must make sure that visa applications are made early enough; Badminton Association of Serbia will provide Official Invitation Letter if this is needed



- Doping Control: Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples. Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE). For more information about anti-doping, please visit the following BWF website LINK
- Badminton Integrity: Section 2.4 of the BWF Statutes (Code of Conduct in Relation to Betting, Wagering and Irregular Match Results) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament. To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, respect the principle of fair play, and shall not attempt to influence the course or result of a game or match. Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a matches. - Compliance with BWF General Competition Regulations Clause 7.9 (GCR 7.9): "In making or authorising entries, the Member concerned is reconfirming its acceptance, and acceptance by the Players being entered, of the BWF's regulations and Disciplinary processes."



- Important remark I: Member who has entered the player/pair into BEC U17 Circuit Tournament is responsible for paying the entry fees for that player/pair; the entry fees become due if a player is entered and has not been withdrawn when the entry deadline passes (has to be paid by bank transfer or cash)
- Important remark II: In accordance with regulation § 9.2 and § 9.3 in BWF Statutes, Section 5.3.3.2: World Junior Ranking System, an event must contain at least 8 (eight) competitors in the first published version of the main draw. If the required number of competitors is not met in the first published version of the main draw, this particular event shall not count towards any ranking. In accordance with regulation § 9.4 in BWF Statutes, Section 5.3.3.2: World Junior Ranking System, an event must contain at least 1 (one) entry from a Member other than the hosting Member in the first published version of the main draw. If an event does not contain at least 1 (one) entry from a Member other than the hosting Member in the first published version of the main draw. If an event does not contain at least 1 (one) entry from a Member other than the hosting Member in the first published version of the main draw, this particular event shall not count towards any ranking. BADMINTON EUROPE is not liable for any costs incurred by third persons (players, coaches, umpires, team managers etc.) because of an event not having enough competitors to count for the rankings.



- Important remark III: competition schedule will be made after the draw; the maximum number of matches allowed per day will be in accordance with article 6.1.5 of BEC U17 Circuit Regulations; a maximum of 3 rounds per event, per day are allowed to be played in the tournament
