



<b>Eligibility</b>	Slovenian Badminton license for Slovenian players, foreign players have to be member of an Association affiliated to BWF. According to BWF regulations - players who are under 19 years of age throughout the year 2022 (born on or later than 1 <sup>st</sup> January 2004).						
<b>Entries</b>	All entries must be made by using the BWF Online entry system. Entries must be submitted no later than: Tuesday 16 <sup>th</sup> August 2022 at 23:59 BWF HQ time

<b>Draw Size</b>	<p>MS=64, WS=64, MD=32, WD=32, XD=48.</p>
<b>Limitation</b>	<p>The maximum number of competitors (players/pairs) accepted in the tournament is 64 in the singles events, 32 in the doubles and 48 in the mixed doubles.          In accordance with regulation § 9.2 and § 9.3 in BWF Statutes, Section 5.3.3.2: World Junior Ranking System, an event must contain at least 8 (eight) competitors in the first published version of the main draw. If the required number of competitors is not met in the first published version of the main draw, this particular event shall not count towards any ranking.          In accordance with regulation § 9.4 in BWF Statutes, Section 5.3.3.2: World Junior Ranking System, an event must contain at least 1 (one) entry from a Member other than the hosting Member in the first published version of the main draw. If an event does not contain at least 1 (one) entry from a Member other than the hosting Member in the first published version of the main draw, this particular event shall not count towards any ranking.</p> <p>BADMINTON EUROPE is not liable for any costs incurred by third persons (players, coaches, umpires, team managers etc.) because of an event not having enough competitors to count for the rankings.</p>

The entry fees become due if a player is entered and has not been withdrawn when the entry deadline passes. It is recommended that the entry fees are paid by bank transfer, but the organizers can accept cash payments at tournaments.          12.2 The entry fees will not be refunded in the case of a withdrawal. For all the withdrawn players the organizers can invoice the entry fee to the relevant Member.</p>

## Clothing and advertising

Color, design, lettering and advertising on clothing shall be regulated by BWF Statutes, Section 5.2.3: Junior Tournament Regulations § 12 to 16. A player violating these regulations shall be penalized by an administrative fine of 50,00 EUR. It is mandatory for the semi-finals and finals that partners in doubles wear the same color of the T-shirt and shorts/skirts. Failing to do so shall result in an administrative fine of 50,00 EUR.

<b>Visa</b>	<p>All participants needing a visa should request for the letter of the participation, providing us with full name, date of birth, passport number, date of issue, place of issue and date of expiry for all players and officials latest till 16<sup>th</sup> August 2022.</p> <p>After entering player(s) in the tournament, it is the Member's responsibility to organize visas for their players – if this is needed. It is the Member's responsibility to make sure that visa applications are made early enough.</p> <p>The Tournament Organizers will do everything possible to enable the entered players to get a visa.</p>
<b>Responsibility</b>	The organizing committee does not accept any responsibility for any accidents or theft before, during and after the tournament.
<b>Insurance</b>	Any special medical treatment necessary or hospitalization due to serious illness or injury is at the players' or officials' own expense.
