

## Draw Size

MS=48, WS=48, MD=32, WD=32, XD=32.

## Limitation

The maximum number of competitors (players/pairs) accepted in the tournament is 48 in the singles events, 32 in the doubles and 32 in the mixed doubles.

In accordance with regulation § 9.2 and § 9.3 in BWF Statutes, Section 5.3.3.2: World Junior Ranking System, an event must contain at least 8 (eight) competitors in the first published version of the main draw. If the required number of competitors is not met in the first published version of the main draw, this particular event shall not count towards any ranking.

In accordance with regulation § 9.4 in BWF Statutes, Section 5.3.3.2: World Junior Ranking System, an event must contain at least 1 (one) entry from a Member other than the hosting Member in the first published version of the main draw. If an event does not contain at least 1 (one) entry from a Member other than the hosting Member in the first published version of the main draw, this particular event shall not count towards any ranking.

BADMINTON EUROPE is not liable for any costs incurred by third persons (players, coaches, umpires, team managers etc.) because of an event not having enough competitors to count for the rankings.

## Entry fees

BEC Junior Circuit Regulation 12.1: The Member that enters a player/pair into a BEC Junior Circuit tournament is responsible for paying the entry fees for that player/pair. The entry fees become due if a player is entered and has not been withdrawn when the entry deadline passes. It is recommended that the entry fees are paid by bank transfer, but the organizers can accept cash payments at tournaments.

12.2 The entry fees will not be refunded in the case of a withdrawal. For all the withdrawn players the organizers can invoice the entry fee to the relevant Member.


## Seeding and draw

## Clothing and advertising

Color, design, lettering and advertising on clothing shall be regulated by BWF Statutes, Section 5.2.3: Junior Tournament Regulations § 12 to 16. A player violating these regulations shall be penalized by an administrative fine of 50,00 EUR. It is mandatory for the semi-finals and finals that partners in doubles wear the same color of the T-shirt and shorts/skirts. Failing to do so shall result in an administrative fine of 50,00 EUR.

All participants needing a visa should request for the letter of the participation, providing us with full name, date of birth, passport number, date of issue, place of issue and date of expiry for all players and officials latest till 15<sup>th</sup> August 2023.

After entering player(s) in the tournament, it is the Member's responsibility to organize visas for their players – if this is needed. It is the Member's responsibility to make sure that visa applications are made early enough.

The Tournament Organizers will do everything possible to enable the entered players to get a visa.

## Doping Control

Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.

Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

Section 2.4 of the BWF Statutes (Code on The Prevention of The Manipulation of Competitions) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.

To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, shall respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a match(es).
