Events: Men's Singles, Women's Singles, Men's Doubles, Women's Doubles, Mixed Doubles. The number of players/pairs to be accepted for the main single events is 32, for the main double events 24.

In accordance with regulation § 9.2 and § 9.3 in BWF Statutes, Section 5.3.3.1: World Ranking System, an event must contain at least 8 (eight) competitors in the first published version of the main draw. If the required number of competitors is not met in the first published version of the main draw, this particular event shall not count towards any ranking, i.e. BEC Elite Circuit Ranking and BWF World Ranking. In accordance with regulation § 9.4 in BWF Statutes, Section 5.3.3.1: World Ranking System, the first published version of the main draw of an event must contain at least 1 (one) entry from a Member other than the hosting Member. If an event does not contain at least 1 (one) entry from a Member other than the hosting Member, this particular event shall not count towards any ranking.

Badminton Europe is not liable for any costs incurred by third persons (players, coaches, umpires, team managers etc.) because of an event not having enough competitors to count for the rankings.

The final frame schedule shall be made at least 20 days before the start of the tournament and shall be published on the organizer's website.

All badminton players who are eligible to play for the BWF Member Associations. Participation is open to players of any national association recognized by the BWF.

Note: The Member that enters a player into a BEC Elite Circuit tournament is responsible for paying the entry fees for that player. The entry fees become due if a player is entered and has not been withdrawn when the entry deadline passes. It is recommended that the entry fees are paid by bank transfer, but the organisers can accept cash payment at tournaments.

The entry fees will not be refunded in the case of a withdrawal. For all the withdrawn players the organisers can invoice the entry fee to the relevant Member.

WITHDRAWALS

Any withdrawal after the January 22, 2024, for any reason whatsoever, renders the Member Association concerned liable to an amount of 150 USD for the inconvenience caused by the withdrawal (as defined in the BWF General Competition Regulations)

Any player not showing up at the tournament, without having been withdrawn in advance, renders the Member Association concerned liable to an additional amount of US\$ 500,00 for the inconvenience caused by the "no show" (as defined in BWF General Competition Regulations).

VISA

Visa arrangement can be made at the Heydar Aliyev International Airport **only** for visitors from countries that does not have Azerbaijan Embassy and does not support e-visa system. To obtain the visa on arrival, Member Associations must send the passport scan (has to be in JPEG, JPG, PNG format and the size must not exceed 5 MB) of their players and officials to

<u>info@badminton.az</u> by January 20, 2024. National badminton federations have to send official letter about all participants from their county including players, coaches, journalists and etc.

INSURANCE

The organizers will not be responsible for any injury sustained, at any time, by any player or official arising from his participation in this Championship. Any costs incurred for medical treatment and/or hospitalization shall be borne by the Member Association of the player/official concerned. All players and officials are recommended to review their insurance cover and ensure that it meets your current requirements.

Member Association and/or Organiser may be liable for claims originating from the damages incurred by the participants and/or any other persons, arising from or in connection to the

particular BEC Elite Circuit tournament, according to local Law. BADMINTON EUROPE is not liable for any such claims, actions, damages, costs or expenses of any nature whatsoever, including but not limited to injury or loss to person or property, arising out of or in any way related, directly or indirectly, to the particular BEC Elite Circuit tournament. It is recommended that Member Associations and/or Organisers purchase a proper Insurance Policy that would cover their potential legal liability.

MEDICAL SERVICES

On courts Doctors and Physiotherapist will be available during the tournament and further information will provided at the team managers meeting.

FURTHER PROVISION

Players shall not plan their departure less than 2 (two) hours after their last match is planned to conclude. If a player is unable to compete due to early departure, he/she shall be penalised by Forfeiture of rewards (removal of Elite Circuit ranking points and shall not be awarded prizes or prize money). Badminton Europe shall propose to BWF that the gained BWF ranking points are also removed.

The organising Member Association can cancel a tournament in case of force majeure. Such cancellation must be announced at least 15 days before the start of the tournament. If a cancellation is announced less than 15 days before the start of the tournament, then the Member Association organising the tournament is liable for any expenses incurred by third persons (players, coaches, umpires, team managers etc.). BADMINTON EUROPE is not liable for any costs incurred by third persons because of a cancellation of a tournament.

MEDIA INFORMATION AND OBILIGATIONS

It is essential that we do all we can to secure maximum publicity for our sport, and It is a condition of entry into BWF Sanctioned Tournaments that each player, if requested by the BWF, the Media Manager or other Tournament officials, is required to undertake a range of media activities. Please refer to BWF Player Commitment Regulations (BWF Statutes 5.3.6) for further details.

It is expected that Member Associations will help facilitate, but not be limited to, Autograph Signings and Player Appearances for fans attending the Championships.

The Championships will work closely with Member Associations, in accordance with BWF Regulations, in order to achieve this. Failure to comply may result in a penalty being applied.

Media Accreditation: Any Media wishing to attend the Championships should apply through Mr. Kanan Hakimov at email (kanan.hakimov@gmail.com), no later than January 20, 2024.

CLOTHING

This tournament will be run in accordance with, but not limited to, the Badminton World Federation (BWF) Statutes, General Competition Regulations (GCR), and BWF World Tour Regulations. In the event of any dispute, the decision of the Tournament Referee will be final. This tournament will strictly enforce the Clothing, Equipment, and Advertising Regulations as outlined in the BWF GCR 20 – 24. This includes restrictions of certain colors for shirts, shorts, and skirts to avoid issues with virtual advertising on TV courts, as per GCR 21.7.

It is mandatory that partners in doubles wear the same colour of the T-shirt and shorts/skirts at all time during play in both the qualification and the main draw. Failing to do so shall result in an administrative fine of 100,00 EUR.

BETTING

There will be betting on offer from this event. Betting is however not allowed to be made by players or officials connected to the event either in person or through a third party. Participants may therefore not make bets on the Event or procure through third parties the making of bets with a betting agency. Participants who, in violation of this prohibition, nevertheless make or procure through third parties the making of bets with betting agencies shall be immediately disqualified from participation in the Event and are liable for legal prosecution. Similarly manipulation of games will be met with disqualification and possible legal prosecution. Any violation mentioned above is also a breach of Player's Code of Conduct and Code of Conduct for Coaches & Officials and will be sanctioned by BWF.

Badminton Integrity

Section 2.4 of the BWF Statutes (Code on The Prevention of The Manipulation of Competitions) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.

To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, shall respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a match(es).

Doping Control

Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.

Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).
