	Exemption (TUE).

	Section 2.4 of the BWF Statutes (Code on The Prevention of The Manipulation of Competitions)

	any way on badminton matches, shall respect the principle of fair play, and shall not attempt to
	influence the course or result of a game or match.  Every person has an obligation to report to the BWF any approaches by anyone to gather inside
	information or to change the outcome of a match(es).
