### **Events:**

Men's singles, Women's singles, Men's doubles, Women's doubles and Mixed doubles.  
The max number of entries which can be accepted in each event are: Men's & Women's singles (64), Men's & Women's doubles (32), Mixed doubles (48)  
If the number of entries exceeds the amount listed above, a selection of entries will be made in accordance with regulation 6.1.6 of the Badminton Europe U17 Circuit Regulations.  
In accordance with regulation § 9.2 and § 9.3 in BWF Statutes, Section 5.3.3.2: World Junior Ranking System, an event must contain at least 8 (eight) competitors in the first published version of the main draw. If the required number of competitors is not met in the first published version of the main draw, this particular event shall not count towards any ranking.  
In accordance with regulation § 9.4 in BWF Statutes, Section 5.3.3.2: World Junior Ranking System, an event must contain at least 1 (one) entry from a Member other than the hosting Member in the first published version of the main draw. If an event does not contain at least 1 (one) entry from a Member other than the hosting Member in the first published version of the main draw, this particular event shall not count towards any ranking. Badminton Europe

is not liable for any costs incurred by third persons (players, coaches, umpires, team managers etc.) because of an event not having enough competitors to count for the rankings. Each player is allowed to play in **3 events**.

The tournament will be played according to the knockout-system in accordance with the rules of BWF and **the Badminton Europe U17 Circuit Regulations**. All matches in all events will be played according to the international rules. Seedings and the draw will be made by Badminton Europe.

**Eligible players:** All players of clubs affiliated their national Associations to the BWF - and born 2009 or later

**Umpires:** There will be scorekeepers in all matches. Umpires and line judges will be present from the semifinals. Please note that Service height measuring device may be present from SF.

**Advertising:** Colour, design, lettering and advertising on clothing shall be regulated by BWF Statutes, Section 5.2.3: Junior Tournament Regulations § 12 to 16. A player violating these regulations shall be penalised by an administrative fine of 50,00 EUR.

It is mandatory for the semi-finals and finals that partners in doubles wear the same colour of the T-shirt and shorts/skirts. Failing to do so shall result in an administrative fine of 50,00 EUR.

**Entry fees:** Entry fees - **to be paid before the tournament** - are:  
Singles: DKK. 425,- (58,- Euro)      Doubles: DKK. 475,- (64,- Euro) per pair.

Shuttles are included in the entry fees. The Member that enters a player/pair into a BEC U17 Circuit tournament is responsible for paying the entry fees for that player/pair. The entry fees becomes due if a player/pair is entered and has not been withdrawn when the entry deadline passes. It is recommended that the entry fees are paid by bank transfer, but the organisers can accept cash payments at tournaments. The entry fees will not be refunded in the case of a withdrawal. For all the withdrawn players the organizers can invoice the entry fee to the relevant Member.

*All players incl. the Danish players will have to go through their national Member Association.*

**Managers meeting:** Managers meeting will be held in the Venue on Friday August 22<sup>nd</sup> 30 mins prior to the first game, but no earlier than 08.00 AM.

**Visa:** It is the Members responsibility to secure visas for their player(s). In case of problems, contact organizer using the emails listed at the end of this invitation as soon as possible, but not later than Friday July 27<sup>th</sup>. Best effort assistance from the organizers will be provided.

**Transport:**

The official point of arrival is Friheden Train Station. (This is the required transport offer)

But we offer to pick up players at the Copenhagen Airport (CPH) as well – for airport pickup please supply flight number and arrival date – then we can follow potential delays

- Friheden Train Station can be reached from Copenhagen Airport Train Station (Ticket counters in Terminal 3). Requires minimum one train shift.
- Transport between CPH Airport or Friheden Station and the official Hotel (only) will be provided by the organizers on request. Price if transport is requested: 75 DKK (10 Euro) per trip per person to be paid on arrival to the tournament.

Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).
