**Entry fees** **Singles: 40** Euro per player  
**Doubles: 30** Euro per player

Entry fees shall be paid before the starting day of the competitions to the bank account of Turkish Badminton Federation. Payment receipt copy should be offered to tournament office before the first scheduled match, Cash Payment is not accepted.

The Member Association that enters a player into a Circuit tournament is responsible for paying the entry fees for that player.

For all the players withdrawing in the time between the entry deadline and the beginning of the Tournament the Organisers can invoice the entry fee to the relevant Member Association.

**Minimum entries:** It is required that every event in a particular BEC Circuit tournament has at least 8 competitors. If the required number of competitors is not met, this particular event shall not count towards any ranking.

In accordance with regulation § 9.4 in BWF Statutes, Section 5.3.3.2: World Junior Ranking System, an event must contain at least one entry from a Member Association other than the hosting Association. If an event does not contain at least one entry from a Member Association other than the hosting Association, this particular event shall not count towards any ranking.

**Visa** If you need Visa for Turkey, ask the Turkish Badminton Federation for the official Invitation letter not later than 21 days before the Tournament . It is advised to arrange the VISA in time.

**Condition of play** The tournament will be played in full accordance with the Laws of Badminton and the Competition Regulations adopted by the BWF as well as the Junior Circuit Regulations. Competitors must be prepared to play at the times determined for the events for which they have entered. Competitors will be scratched if not ready to play when called.

**Clothing and advertising** Clothing and advertising shall be regulated by BWF Statutes, Section 5.2.3: Junior Tournament Regulations § 12 to 16 and BEC junior circuit regulations 13

- Local transport** Provided by the organizer for free between the Ankara Esenboga International airport and the official hotel. Accommodation demands and payments shall be sent directly to the Turkish Badminton, Otherwise Organizer has no responsibility for transport of the participants. ### **Doping Control**

Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.

Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

### **Badminton Integrity**

Section 2.4 of the BWF Statutes (Code of Conduct in Relation to Betting, Wagering and Irregular Match Results) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.

To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a matches.

### **Compliance with General Competition Regulations Clause 7.9**
