Regulations	<p>The Tournament will be played in accordance with the Badminton Europe regulations as laid down in Appendix X (Regulations for the European U15 Championships) and the Laws and Regulations as adopted by the Badminton World Federation.</p> <p>Regulations can be found here</p> <p>The European U15 Championships will be played as a knockout competition.</p>
Participation fee	<p>Player entered in 1 individual event EURO 60,-</p> <p>Player entered in 2 individual events EURO 90,-</p> <p>Player entered in 3 individual events EURO 120,-</p> <p>The participation fees are payable after receipt of the invoice.</p>
Entries	<p>Entries must be made online no later than 13 August 2024 at 23.59 CEST via the link below:</p> <p>https://bwf.tournamentsoftware.com/tournament/E765D24A-BE95-47D3-9B64-F2E924AE8C64</p> <p>Entries can only be submitted in accordance with “Eligibility” as listed below. Any submitted entries not in accordance with this section will be removed and not included into the event.</p>

	Compliance with GCR 7.9: “In making or authorising entries, the Member concerned is reconfirming its acceptance, and acceptance by the Players being entered, of the BWF’s regulations and Disciplinary processes.”
Eligibility	<p>All Badminton Europe Members are eligible to compete in the event.</p> <p>Members are allowed to enter:</p> <ul style="list-style-type: none"> 2 players in men’s singles 2 players in women’s singles 4 players (or up to 2 pairs) in men’s doubles 4 players (or up to 2 pairs) in women’s doubles 4 players (or up to 2 pairs) in mixed doubles <p>The hosting Member is entitled to enter one extra player in each of the single events and two extra players in each of the doubles events.</p> <p>Players are allowed to enter in the 3 events.</p> <p>Participants in the 2024 European U15 Championships shall be restricted to players born in 2010 or later.</p>
Substitution	<p>After the closing date for entries, a player who has entered may be unable to take part through illness, injury, or other unavoidable cause.</p> <p>That player's place in singles or doubles or both can be taken by a player from any Member as long as that Member does not exceed the quota of players for that specific event.</p>

3. Tournament Details

Seeding Date	<p>Seeding shall be done by Badminton Europe and will be based on a point system.</p> <p>Points will be awarded based on results of a selection of Europe U15 tournaments played within a year preceding the European U15 Championships and based on ranking positions in the BEC European U17 Ranking.</p> <p>The seeding will be announced on 20 August 2024.</p>
Draw Date	The draw will be conducted and published on 20 August 2024 .

Practice	An online practice booking form will be made available on the on the event website and on Sportity app and should be done before 3 September 2024 .
Stringing	Badminton Europe's official event partner and equipment supplier, YONEX, will provide stringing service throughout the whole event.
Team managers Meetings	The Team Managers' Meeting will be held on 10 September 2024 - 8pm at the Venue. All participating Members must be present at the meeting.
Provisional schedule	<p>Wednesday 11 September: Round of 128 and Round of 64 (from 9h) Thursday 12 September: Round of 64 and Round of 32 (from 9h) Friday 13 September: Round of 32, Round of 16 and Quarter Finals (from 9h) Saturday 14 September: Semi Finals and Finals (from 9h)</p> <p>Please note that this is only a provisional schedule. If possible, we will try to play only the finals on 14/09. The final schedule will be published shortly after the entry deadline.</p>
Technical Official briefing	The Technical Official briefing will be held on 10 September 2024 - 9pm at the venue.
Medal ceremonies	All medals will be presented on Sunday 14 September 2024 after the respective finals. All medalists are required to be present at the medal ceremonies.

<p>Clothing and advertising</p>	<p>Clothing and advertising will be permitted in accordance with the regulations of Badminton Europe's Appendix X – "European U15 Championships", regulations 11 and 12.</p> <p>The name of the player on the back of the shirt is optional. (if used, please note that it must comply with BWF rules)</p> <p>The name of the player's country on the back is optional. (if used, please note that it must comply with BWF rules)</p> <p>In applying regulations on clothing and designs and advertising on players' clothing the decision of the Referee shall be final.</p>
<p>Badminton Integrity</p>	<p>Section 2.4 of the BWF Statutes (Code on The Prevention of The Manipulation of Competitions) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.</p> <p>To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, shall respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.</p> <p>Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a match(es).</p> <p>For more information, please refer to BWF's website: Anti-Match Fixing</p>

<p>Doping control</p>	<p>Anti-doping testing may be carried out on a random basis at any time, as per BWF and WADA regulations.</p> <p>Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.</p> <p>Athletes are responsible for any substance found in their body.
